<p><b>Who can use this form?</b></p>	<p>People with Medicare who want to join a Medicare Advantage Plan</p>
<p><b>To join a plan, you must:</b></p>	<ul style="list-style-type: none"> <li>• Be a United States citizen or be lawfully present in the United States.</li> <li>• Live in the plan's service area.</li> </ul> <p><b>Important:</b> To join a Medicare Advantage Plan, you must also have both:</p> <ul style="list-style-type: none"> <li>• Medicare Part A (hospital insurance).</li> <li>• Medicare Part B (medical insurance).</li> </ul>

The items in section 2 are optional — you can't be denied coverage because you don't fill them out.</p>
